#### 2. APPLICABLE LEGISLATION RELATING TO DATA PROTECTION OF COLLECTING OF PERSONAL DATA

# 6. RIGHTS OF THE DATA SUBJECT

- Subject can demand the access to personal data, declared by data regulation, right of erasing or correction of this data, or to limit of processing them, right of to decline to not disagree to collect and process your personal data, furthermore is kept your right of portability of your personal data.
- If you suppose that by processing of your personal data was observed or is observed your right of data regulation, you are entitled to make a complaint at control office.

  to execute the contract by controller.
